## **Boyd and Jane Wear Use Their Experience to Support Others**

In one year, 57.7 million Americans experience a mental health disorder, according to the National Alliance on Mental Illness. This means 1 out of 17 people in the U.S. lives with a mental illness, and only 60% of those struggling receive mental health care. Therefore, many family members and friends play a large role in helping support those with a mental illness.

These statistics have become very personal for Boyd and Jane Wear, as they have a close family member who lives with a mental illness. They have experienced firsthand the challenges families



have to navigate to get help for their loved ones. Barriers, such as a lack of local resources, can be daunting. The Wears have met several other families in the Kosciusko community who also have trouble navigating the system, learning coping strategies, advocating for their loved one and identifying sources of support. Most have to travel to Fort Wayne for classes or support groups.

This is why Boyd and Jane started the Kosciusko County Mental Health Services Fund. They wanted to establish a local resource for family and friends of those living with a mental illness and put means in place to guide people through crisis. Boyd and Jane anticipate the growth of the fund and are

hoping more community members will support the cause. "Establishing the fund is just the first step," Jane explained. "We are also wanting to begin a support group for the families of those living with a mental illness. We want to work with mental health care entities and other resources in the community to form a strong network."

Through her work at Cardinal Services in Kosciusko County, Jane learned there is always room for improvement in helping others. Over the 40 years she was at the organization, she worked with people with developmental disabilities and helped evaluate their work skills for potential job opportunities. She was the CEO of the organization for 20 years before she retired.

After receiving his degree in mechanical engineering, Boyd worked for Dalton Foundry until 2009 when he started working for Warsaw Engineering and Fabricating. Together, Boyd and Jane share many favorite interests. They love to travel to national parks and anywhere else they can hike and enjoy the outdoors. They both serve on scholarship review committees at the Community Foundation, volunteer as cancer patient drivers and attend Warsaw Community Church.

Boyd and Jane appreciate the progressive, vibrant community of Kosciusko County and the way people come together to accomplish things for the greater good. They would encourage future generations not to lose sight of a desire to assist others. "It's all about people," Jane shared. "It's not about stuff. Life is about helping, mentoring and supporting others." Boyd concluded with the simple mantra, "It doesn't cost anything to be kind." Through their desire to lend a helping hand to the families of those experiencing a mental health condition, Boyd and Jane Wear are leaving a shining legacy in Kosciusko County.
