APPLYING FOR A GRANT

Grant seekers are strongly encouraged to contact the Community Foundation's program staff to discuss your grant proposal prior to submitting a formal application to ensure eligibility.

The Community Foundation and AWS Foundation support the Guiding Principles for this fund, as listed on this page. Applicants <u>must</u> describe how how the request meets one more of the Guiding Principles and serve Kosciusko County residents.

THE COMMUNITY FOUNDATION WILL <u>NOT</u> <u>CONSIDER</u> GRANTS FOR:

- Individuals
- Political activities or those designated to influence legislation
- National organizations (unless the monies are to be used solely to benefit citizens of Kosciusko County)
- Fund-raising projects
- The direct benefit of the donor or the donor's family
- Religious organizations for the sole purpose of furthering that religion (this prohibition does not apply to funds created by donors who have specifically designated religious organizations as beneficiaries of the funds)*
- Contributions to endowments*



GUIDING PRINCIPLES:

- Individuals with disabilities deserve a choicedriven life (self-determination). Preferences, opinions, priorities and accommodations are best defined by the individual rather than for the individual.
- Inclusion and integration are better than segregation. The more inclusive and integrated an environment, activity or program, the more it benefits everyone.
- Opportunities are presented with a focus on encouraging potential, rather than identifying limitations.
- Social settings that include **family and friends** are preferred. Age-related peer groups and the potential for new friends are ideal.
- ADA standards are the law and the minimum.
 Exceeding through the principles of Universal Design is desirable.
- Opportunities that enhance and support education and employment potential will contribute to greater independence for the individual.
- No one has all the answers. Collaboration increases the potential for greater opportunities.
